Garden Fresh Salsa

Ingredients

- 2-3 med. tomatoes, quartered
- 1 bunch green onions, chopped
- 1-2 cloves garlic
- 1 mild green chili, seeded and cored
- 1 handful cilantro, long stems trimmed
- 1 Tbsp. lime juice or apple cider vinegar
- ½ tsp. salt, or to taste
- ½ tsp. sugar, or to taste
- dash cumin
- dash paprika or chili powder, to taste

Process garlic, chili, onion, cilantro and lime juice in food processor for 10-20 seconds. Add tomatoes and process until chunky consistency, stopping occasionally to scrape sides and rearrange any large tomato chunks. Add salt, cumin, sugar, paprika or chili powder to taste. Refrigerate at least one hour to allow flavors to blend. Serve with a wedge of lime and Sage Valley Yellow Corn Tortilla Chips.
